# **Motion of Condolence**

During his tenure as India's Prime Minister for two consecutive terms from 2004 to 2014, he initiated several structural reforms to liberalise the nation's economy.

#### **Motion of Commendation**

The Academic Council of Mahatma Gandhi University takes great pride in commending the significant achievements and initiatives that highlight our institution's progress in education, research, entrepreneurship, collaboration, and numerous other domains.

Mahatma Gandhi University has made remarkable progress in the Times Higher Education World University Rankings for 2025, securing a position in the 401-500 rank band, a notable improvement from last year's 501-600 rank band. This achievement reflects the University's excellence in teaching and research, evaluated across 18 key performance indicators. The Academic Council extends its heartfelt commendation to the Honourable Vice Chancellor, Prof. (Dr.) C.T. Aravindakumar, and the entire University community for this outstanding accomplishment.

The Council also appreciates the successful coordination of the visit by the Honourable Chancellor of Mahatma Gandhi University and the Governor of the State, Rajendra Vishwanath Arlekar. This event was made possible through the diligent efforts of the Honourable Vice Chancellor, Syndicate members, faculty, and non-teaching staff.

In the Institutional Ranking Framework 2024 of the State Government, Mahatma Gandhi University secured third place in the university category, underscoring its

commitment to excellence. The Academic Council congratulates the Honourable Vice Chancellor and all contributors to this success.

The University has also earned international recognition for its pioneering role in higher education by becoming the first in the country to establish a unit of the University of the Third Age (U3A), an international organisation. The Mahatma Gandhi University U3A Unit will be presented as a model from India at the upcoming International Conference of the Association of International Universities of the Third Age, which will take place at Hong Kong Metropolitan University on March 31. The facility was inaugurated on October 22 by the Honourable Minister for Higher Education and Social Justice, Dr. R. Bindu. The Academic Council expresses its appreciation to the State Government for funding this project, which will enhance the University's sports infrastructure and benefit the wider Kottayam district. Special recognition is also given to the Honourable Vice Chancellor for his leadership in realising this project, as well as to Prof. (Dr.) Binu George Varghese, Head of the School of Physical Education and Sports Sciences, for coordinating the activities, and to all those involved in the successful organisation of the inaugural ceremony.

The University also acknowledges the appointment of Prof. Dr. Bismi Gopalakrishnan as the new Registrar of Mahatma Gandhi University on October 3. Mahatma Gandhi University has also strengthened its academic and research collaborations by signing MoUs with the Institute of Physics, Belgrade (IPB), Serbia, and the Centre for Water Resources Development and Management (CWRDM), Kozhikode. The Academic Council commends Registrar Dr. Bismi Gopalakrishnan, Archives Coordinator Dr. P.M. Arathy, and their team for their efforts in creating this invaluable resource.

The Council also congratulates former Vice Chancellor and Director of the School of Nanoscience and Nanotechnology, Prof. Sabu Thomas, on receiving an Honorary Professorship from Satbayev University, Kazakhstan, and an Honorary Doctorate from Mines-Telecom Institute, France.

Former diplomat Venu Rajamani has assumed charge as the Chair Professor of the K.P.S. Menon Chair at the School of International Relations and Politics.
