- The effective date of registration for all research scholars in the approved Research Centres, shall be the date of commencement of course work in the Research Centre.
- In the case of candidates eligible for Any time registration, the effective date of registration shall be the date of joining the research centre after obtaining the registration order.
- The registration granted will be confirmed only after the successful completion of the Course Work .
- **All the Scholars should submit their original Transfer Certificate to the Research Centre/Department at the time of joining as per the U.O read (7) above and Proper entries must be made by the Research Centre or Department in the admission register regarding this.**  
**Transfer Certificate of PhD Courses should be issued by the Centre or Department (in case of Cancellation of registration or after submission of Thesis) only after receiving the NOC from the University.**
- **Joining report in the new format shall be submitted by the Head of the Department/ Principal of the Research Centre within ten days from the date of joining.**
- The maximum and the minimum period of research is as per MGU Ph.D. Regulations 2016.
