### ORDER

As per the Government order read as Paper (1), all the University examination fees & other fees are to be increased by 5% for the Academic Year 2019-20 and at the same rate every subsequent academic years.

The Vice-Chancellor, by exercising the powers under Section 10 (17) Chapter III of the Mahatma Gandhi University Act 1985, accorded sanction to increase all the University examination & other fees @ 5% for the year 2025-2026 incorporating the following fees revision proposals.

- To revise foreign currency rate from 56 USD To 59 USD for the following category of fees:

Re-verification fee for Official Transcript of a Programme
Re-verification fee for Genuineness verification of Grade Cards/Mark List of a Programme
Re-verification fee for Genuineness verification of Degree Certificate of a Programme

- Re-verification fee is limited to a maximum of 178 USD for one programme
- Fees related to research

- Fee for ID Cards at the time of admission -160
- Fee for Student Welfare Fund - 70
- To include the fees of medical / para medical programmes effecting increase @ 5 %.
