<u>ORDER</u>

The Principal, M.E.S Training College, Edathala vide the Paper read as (1) above, submitted an application for the affiliation of two new Optional subjects "Malayalam" and "Arabic" for the B.Ed programme, within the sanctioned strength of 100, starting from the Academic year 2025-'26, by re -apportioning the seats earmarked for the existing Optional subjects.

The University vide the Papers read as (2) & (3) above, constituted an Inspection commission to assess the infrastructural and instructional facilities in the College. After conducting the inspection, the Commission submitted its report with favourable recommendations.

The Vice- Chancellor by exercising the powers conferred upon him by virtue of Section 10(17), Chapter III of the Mahatma Gandhi University Act 1985, accorded sanction to commence two new Optional subjects "Malayalam" and "Arabic" for the B.Ed programme at M.E.S Training College, Edathala (Unaided) by re-apportioning the seats earmarked for the existing optional subjects, from the Academic year 2025-'26, as detailed below.
