The engagement will be purely on contract basis for the **2025-2026 academic year** or till permanent appointment in the post concerned is made, whichever is earlier. I. ELIGIBILITY

1. **Age** : As per UGC Regulations regarding appointment of Assistant Professors. Teachers

who retired from Colleges/ Universities will also be considered subject to the condition that the maximum age limit shall be 70 years as on 01.01.2025.

2. **Qualification:** Two year LLM with UGC-NET .

3. **Remuneration:**

Consolidated pay of ₹ 40,000 /- per month for UGC qualified candidates.

II. GENERAL CONDITIONS

1. The appointment will be purely on contract basis for the **2025-2026 academic year** or till permanent appointment in the post concerned is made whichever is earlier.
2. Applicants for post under community reservation quota shall submit community certificate issued this year by the authorities concerned.
3. Natives of states other than Kerala need not apply for the post notified exclusively under community reservation quota.
4. Degree obtained from Universities/ institutions outside the state of Kerala shall be accompanied by equivalency/eligibility certificate obtained from this University.
