The Kerala State Higher Education Council had selected Dr. Alex Joseph, for the Chief Minister's Nava Kerala Post Doctoral Fellowship. The scholar joined as Nava Kerala Post Doctoral Fellow at the School of Chemical Sciences, Mahatma Gandhi University on 10.07.2023.

As per paper read as (1) above, the KSHEC had sanctioned Rs.2,00,000/- (Rupees Two Lakh only) towards the first year contingency grant as part of Chief Minister's Nava Kerala Post Doctoral Fellowship to Dr. Alex Joseph. The released amount had been credited to the account of Dr. Alex Joseph vide reference (2).

Vide reference cited (3), the KSHEC has sanctioned Rs.1,72,718/- (Rupees One Lakh Seventy Two Thousand Seven Hundred and Eighteen only) towards the second year grant and the same has been credited to University account and entry No. 12104 dated 07.07.2025 has been made in RR accordingly.

Considering the above, sanction has therefore been accorded by the Vice Chancellor to release an amount of Rs.1,72,718/- (Rupees One Lakh Seventy Two Thousand Seven Hundred and Eighteen only) to the account of Dr. Alex Joseph. (**Account No:67015695432, IFSC:SBIN0070886**)

The expenditure on this account shall be debited to the head of account "23 703 34 - Post Doctoral Fellowship from External Agencies" provided in the budget estimates of the current financial year (2025-26)
