ORDER

A few candidates of Three Year Unitary LLB regulations (2018 onwards) / Five Year Integrated Double Degree LLB (2018 onwards) filed writ petitions before the Hon'ble High Court of Kerala, seeking permission to apply for Internal Redo. Based on the interim orders of the Court, the students were allowed to apply for the Internal Redo. However, orders regarding publication of results has not been mentioned in the final judgements.

The Vice-Chancellor, by exercising the powers under the Section 10(17), Chapter III of the Mahatma Gandhi University Act 1985 has approved the opinion of the Convenor, Expert Committee of Law vide paper read as (3) above to publish the results of Internal Redo of the students, who had filed writ petitions before the Hon'ble High Court, subject to the final Orders of the Court and recommended to cancel the below mentioned clauses of the Paper read as (1) and (2) above.

- **Annexure 1: Clause 3** "The candidates who fails to score more than 50% of the aggregate 25 marks (rounded off to 13 marks) in theory paper(s) in the regular internal assessment alone shall be eligible to redo the internal assessment"
- **Clause 5.** "The eligibility for redoing internal assessment shall generally be limited to one paper for every semester. Provided that, if any student has not availed the benefit of redoing the internal marks in a paper in any semester, the eligibility for the same may be carried forward to any paper in any other semester, subject to a maximum of TEN papers in total for the entire Course/Programme." are cancelled accordingly.

As per the Orders of the Vice Chancellor dated 10.07.2025 vide Paper read as (4) above, Students who have applied for Internal Redo, and were not registered for the last Supplementary examination shall be permitted to register for the respective subjects in the said examination.

Orders are issued accordingly.
