Inviting Expression of Interest- for Providing Consultancy services for the work of renovation/updation of Electricity Distribution System in the Mahatma Gandhi University Campus

Carryout Design & Detailed Engineering (including Technical Specification & Scope of Work, implementation schedule etc.) of the 11 KV receiving station, RMUs, UG/ areal cabling, control panels safety equipments etc. as per requirement upon Kerala State Electrical Inspectorate & Kerala State Electricity Board's approval of the Consultant's recommendations.
- v. Preparation of indicative QAP for all critical machineries/equipments/materials and critical works to be included in the tender;
