ORDER

The Educational Agency Kocheries Foundation (Hope Charitable Trust), Kanjiramattom, Ernakulam was accorded sanction vide the Order read as Paper (1) above, to start a New Unaided Law College by the name, 'Kocheries School of Law, Kanjiramattom' with B A LL.B programme and an intake of 50 students for the Academic Year 2025-'26, subject to the following conditions.

- to obtain an Affidavit from the Trust Chairman to the effect that the deficiencies reported by the Inspection Commission will be rectified by ensuring all the necessary facilities for starting the College.
- to obtain approval from the Bar Council of India (BCI) and NOC from the Government of Kerala

To facilitate the application for obtaining recognition from the Bar Council of India, the Chairman, Kocheries Foundation (Hope Charitable Trust), Kanjiramattom, Ernakulam vide application read as Paper (2) above, requested an extension of the permission granted vide U.O. read as Paper (1) above, for the Academic Year 2026-'27 .

The Syndicate Standing Committee on Affiliation, at its meeting held on 10.09.2025, considered the request received from the Chairman, Kocheries Foundation (Hope Charitable Trust), Kanjiramattom, Ernakulam (Educational Agency) and vide Item read as Paper (3) above, resolved to extend the permission granted to start new Unaided Law College as per the U.O. read as Paper (1) above, by the name 'Kocheries School of Law, Kanjiramattom' , for the Academic Year 2026-'27.

The Vice Chancellor, by exercising the powers under Section 10 (17) Chapter III of the Mahatma Gandhi University Act 1985, approved the recommendation of the Syndicate Standing Committee on Affiliation, vide the Minutes item read as Paper (3) above.
