Submission and Formatting guidelines

- All submissions must be in the Microsoft word Format in Times New Roman with font size 12 and line spacing of 1.5
- Citations must conform to the Bluebook (21 st edition) style of citation
- Footnotes must be in Times New Roman, font size 10 with single line spacing
- All submissions must be original and unpublished work of the author and should not have been submitted, accepted or published elsewhere.
- Submit an electronic copy of your manuscript along with a covering letter mentioning the name of the author ,occupation ,title of manuscript, mobile phone no and contact address.
- Plagiarism report must accompany the covering letter and the manuscript.(Similarities up to 10% alone will be permitted)
- Articles found plagiarized will be summarily rejected
- Co-authorship is allowed (maximum of 2 authors)
- Articles will go through a double blind peer review and acceptance will be subject to the report of the peer review team. Please send a **plagiarism check report** along with the article. Articles without the report will not be entertained.
