ORDER

The Higher Education Department of Kerala, vide Order read as (1), created two additional seats for admitting Students belonging to the Transgender category, in all Law Colleges in the State, over and above the existing Sanctioned strength, subject to the approval of the Bar Council of India.

In compliance with the Interim Order of the Hon' High Court of Kerala Dated - 24.10.2025 in WP(C) No. 30999/2025, the Bar Council of India, as per Paper read as (3) above, granted interim approval for creating **two supernumerary seats in the Five-Year Integrated LL.B and Three-Year Unitary LL.B programmes in each Law College in Kerala for the Transgender category during the Academic Year 2025-26**. These two seats shall be over and above the existing sanctioned intake and shall not reduce or disturb the seat matrix of other categories. This interim approval applies to all the Law Colleges in Kerala approved by the Bar Council of India to impart legal education during Academic Year 2025-'26.

The Commissioner for Entrance Examinations (CEE), Kerala, vide Paper read as (4), requested the University's approval for admitting Transgender students to these two additional seats in all Law Colleges affiliated to Mahatma Gandhi University for the Academic Year 2025-26.

Considering the directions of the Hon' High Court of Kerala, Bar Council of India and the State Government, the Professor-in-charge of the Vice Chancellor by exercising the powers under Section 10 (17) Chapter III of the Mahatma Gandhi University Act 1985, has granted approval for admission to two additional seats for Transgender category in Integrated Five Year LL.B and Three Year Unitary LL.B Programmes in all Law Colleges affiliated to Mahatma Gandhi University for the Academic Year 2025-'26.

Orders are issued accordingly.
