### ORDER

As per the U.O. read as Paper (1) above, provisional approval was granted to Bharata Mata School of Legal Studies, Choondy, Aluva, for conducting the Three-Year Unitary LL.B Programme, subject to the receipt of Administrative Sanction and NOC from the Government of Kerala, and approval from the Bar Council of India, for the Academic Year 2025–26.

Consequently, the College approached the Bar Council of India (BCI) for approval. The BCI, vide its letter read as Paper (2) above, granted approval of affiliation to Bharata Mata School of Legal Studies, Choondy, Aluva, Ernakulam, Kerala, for offering the Three-Year Unitary LL.B Programme with an intake of one section of 60 students along with an additional section of 60 students, i.e., two sections of 60 students each, for the Academic Year 2025–26.

The Government of Kerala, vide its Orders read as papers (3) and (4) above, accorded Administrative Sanction and issued the No Objection Certificate, respectively, to Bharata Mata School of Legal Studies, Choondy, Aluva, for conducting the Three-Year Unitary LL.B Programme for the Academic Year 2025–26.

The Syndicate at its meeting held on 31.10.2025 considered the matter in the light of the aforementioned documents and, vide Minutes read as Paper (5) above, resolved to grant provisional affiliation to an additional batch of Three year Unitary LL.B programme in Bharata Mata School of Legal Studies, Choondy, Aluva, for the Academic Year 2025-'26 as detailed below:

The Provisional affiliation granted is subject to the following conditions:

1. The Provisional affiliation granted is for the Academic year 2025-'26 only.
2. The programme shall be conducted as per the approved scheme and syllabus.
3. The admission of the Students and commencement of classes for the said programme in the College shall be in accordance with the rules and regulations of the University and Bar Council of India.
4. The Educational Agency shall furnish an Undertaking in a stamp paper with face value of Rs 200/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Govt. and Bar Council of India regarding the admissions to the programmes from time to time.
5. The institution shall observe the admission norms regarding the eligibility of candidates and the norms of reservation framed by the Government, Commissioner of Entrance Examinations, University and Bar Council of India.
6. The College shall remit an amount of Rs.51,060/- +18% GST towards course affiliation fee (initial affiliation) for each programme.
7. The Educational Agency shall set apart 50% of the seats of the Courses for being filled up by the Govt or such authority determined by the Government and remaining 50% filled by the Educational Agency on the basis of merit provided they satisfy the eligibility conditions prescribed by the University.

  - a) The details of Tuition fee and other fees are as detailed below:

- b) Students Insurance Premium - Rs.100/- per student per year
- c) Students welfare fund - Rs.50/- per student per year
- d) University Union Fees - Rs.100/- per student per year

- e) Sports Affiliation Fee due to the University - Rs.270/- per student per year
- f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's Affiliation fee - Rs. 1325/- collected on one time basis from all students shall be remitted to the University within 15 days after closing admission.
9. The College shall submit the list of Students admitted and remit the fees due to University within 15 days after closing the admission.
10. There shall not be any financial commitment to the Govt./University.
11. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the provisional affiliation without any prior notice.

Orders are issued accordingly.
