Pursuant to the Addendum Notification issued by the Hon'ble Chancellor vide reference (3), the University Notification cited as reference (2) is modified as follows:

The words "in addition to his normal duties" is added to the first paragraph of the original notification. Hence, the modified section now reads:

"As per paper (1) above, it is notified that, in exercise of the powers conferred by sub section 25 of section 10 of the Mahatma Gandhi University Act, 1985, read with clause 7.3 of the UGC Regulations, 2018, the Hon'ble Chancellor of the University is pleased to order that pending appointment of a person as Vice Chancellor on a regular basis, as against the permanent vacancy of the Vice-Chancellor available in the University, Dr. Mavoothu D., Professor & Former Director, School of Management Studies, Cochin University of Science & Technology, shall exercise the powers and perform the duties of the Vice Chancellor, Mahatma Gandhi University, with immediate effect, in addition to his normal duties, until further orders"

The University Notification read as (2) above stands modified to this extent.
