ORDER

The time limit for submitting applications by affiliated Arts and Science Colleges for the grant of marginal increase in seats in UG/PG programmes for the academic year 2026–27 was extended vide the order read as Paper (1) above.

The Principal of Government Sanskrit College, Tripunithura vide the letter read as Paper (2) above, submitted an application seeking a marginal increase in seats for various programmes conducted in the College. However, further processing of the application was deferred by the University due to the existence of fee arrears payable by the College to the University.

Subsequently, as per the orders of the Hon'ble Vice-Chancellor, the Principal submitted a duly signed affidavit, undertaking that all fee arrears due to the University since 2011 would be remitted within a period of two months.

Considering the affidavit submitted by the Principal, and as a special case, sanction is hereby accorded by the Vice - Chancellor, for granting marginal increase in seats over and above the sanctioned intake for the academic year 2026 -27, as detailed below.

Details of Marginal Increase of seats sanctioned for PG programmes for the Academic Year 2026-'27:

The Marginal Increase of seats shall be subject to the following conditions:

1. There shall be no additional financial commitment by way of staff, equipment, building or any other kind to the University/Government.
2. There shall be sufficient library and laboratory facilities for the increased number of seats.
3. Admission of candidates shall be within the sanctioned strength and marginal increase granted.

4. List of candidates admitted to the programme shall be forwarded to this office with details of remittance of fees due to the University as prescribed.

5. In addition to the above, conditions mentioned in the Admission Notification are applicable for the marginal increase of seats as well.

Orders are issued accordingly.
