Inviting Expression of Interest- for Providing Consultancy services for the work of renovation/updation of Electricity Distribution System in the Mahatma Gandhi University Campus

Mahatma Gandhi University, P.D. Hills, Kottayam, invites Expression of Interest (EOI) from experienced firms **registered / operating in the State of Kerala** with proven technical and financial capabilities for providing consultancy services for the work of Renovation / updation of Electricity distribution system in the University campus, henceforth referred to as Applicants, for shortlisting in respect of the work for providing such technical services.

1. Scope of Work of Consultants mainly include the following:-
 - i. Assessment and survey of existing incoming 11KV and outgoing LT distribution system, transformers and control panels in the main campus, connected load and installations in each buildings and to conduct study for the improvement of the same as per updated standards and futuristic requirements.
 - ii. Formulate and submit the recommendations on the modifications to be provided for the updation of the system
 - iii. Recommend a suitable methodology of work and schedule of execution of work considering the requirement.
 - iv. Carryout Design & Detailed Engineering (including Technical Specification & Scope of Work, implementation schedule etc.) of the 11 KV receiving station, RMUs, UG/ areal cabling, control panels safety equipments etc. as per requirement upon Kerala State Electrical Inspectorate & Kerala State Electricity Board's approval of the Consultant's recommendations.
 - v. Preparation of indicative QAP for all critical machineries/equipments/materials and critical works to be included in the tender;
 - vi. Preparation of detailed estimate of proposed System;
 - vii. Assistance during Tendering including attending pre-bid meeting and preparation of replies to the queries raised by bidders, evaluation and finalization of tenders of the work.
 - viii. Assistance during Contract execution of work by deploying appropriate expertise including site visits as per requirements during the tenure of contract.
2. Short listed applicants will be given the Brief of the project for submission of their respective Concept designs and Financial proposal for selection.
